## Dufry successfully extends World Duty Free concession at Jersey airport for 10 years

Following a comprehensive tender process, Dufry has entered into a 10-year agreement with Ports of Jersey – Channel Islands – to continue to provide tax and duty free items under the World Duty Free brand in the airside departures lounge at Jersey Airport.

The new contract, which comes into place on 01 March 2017 will see an increase in the overall size of retail floor space by 260 m<sup>2</sup>, thus reaching a total of 750 m<sup>2</sup>. The space extension will allow for the introduction of new products, more local products and a redevelopment of the retail layout, which is planned to start at the end of summer 2017. Just under 1.6 million passengers used the Island airport in 2016 and the enhanced retail offer will deliver a world class airport shopping experience to travelers.

Julián Díaz, CEO of Dufry, comments: "We are extremely pleased to have reached this agreement with Ports of Jersey and would like to thank the management team for renewing their trust in World Duty Free and Dufry. We have always worked in close partnership and value the relationship we have built up over the years.
